# 8. DEPARTMENTS REPORTS: General Manager Report:

8.1 Maintenance -Mr. Villalpando- here at Bear Mountain Park we have repainted some of the benches, I'm also getting estimates for a new sign to go across the building our nets and goals are up in the tennis area we are just waiting on an opening day, in Weedpatch Park we are taking care of a lot of the gophers I'm looking for different machinery we can use so we don't have to spend that much money on the poison and it's a lot of time consuming as well and we are having issues on the people taking the grills, I'm replacing them, and the pools aren't as clean as usual with the new energy saving pumps they put in it seems that it saves a lot of power but in return we are spending more money on chemicals and more maintenance on the pool being there and in order for the pool to run at its full potential I have to bypass that energy box to the regular energy that we used to use so it makes no sense to have the new pumps because the chemicals are more expensive than the few bucks will be saving on electricity, I've also talked to Eran from Lighting Electric who has had one of those installed in one of his pools and he suggested to stay away from it and the pools have been at there worst when the energy pumps were installed I don't know if there is something we can do to get them removed Mrs. Cervantes- Mr. Hodges and myself have been working on looking at the agreements that we singed and the contracts cause they are not working for us like they were supposed to be working so right now he is trying to see if there is any way that we can get out of the contract since it's not working for us Mr. Villalpando- in everything else were taking care of everything else Mr. Rodriguez- is there any way that you can weld the grills down Mr. Villalpando- they are welded down I just think that because they are so close to the road its easier for them to take it I just think we should not put one on there

- anymore **Mr. Alonso-** what is the statues of the restrooms Mr. Villalpando- there still closed.
- 8.2 Recreation- Mrs. Gonzalez- tonight we were going to have some coaches coming in but the coach that was going to speak had to leave to the hospital, there is a travel team that was made after our soccer league what we wanted to see if they can use our park and our insurance to continue playing travel ball with the kids we got from our league Mrs. Villanueva- Mr. Hodges recommendation is that we can't provide insurance because the team is not one hundred percent ours and for that reason our insurance in this situation, the other recommendation that he suggested that you guys look for an organization that will provide insurance and respect to the gentleman that is out here being vulgar is that we go to the county to report him Mrs. Loza-correct me if I'm wrong are this coaches the same coaches that we have during the season Mrs. Gonzalez- yes they are Mrs. Loza- so why can't we support them Mrs. Cervantes- it's a policy that we have to follow we just can't do it our insurance wouldn't allow it maybe we can find another way but our insurance will not allow it, what we need to do is get rid of that man that its taking over our park Mrs. Villanueva- this situation is not new in the past we wanted to do certain things in benefit to the park and we couldn't use the insurance the insurance has its own rules that doesn't allow us to use it Mr. Rodriguez- so this has been going on for a long time him taking over the park Mrs. Cervantes- yes it has been going on for years what we want to do is come up with an ordinance that what is done at our parks without permission they will be fined, Mr. Hodges is already working on a draft were his putting everything is going to get fined for he drives his truck on the park, he sells food sales jerseys as well it's starting to look like a swap meet Mr. Rodriguez- if this has been going on for so long why haven't done anything to take care of this problem Mrs. Cervantes- Mr. Hodges recommended that anytime he was doing anything to call the cops so we have called the cops on him we have gotten security when we had the security she kept him of the fields but we can't have security all year around we do it when she has her season so she can feel safe when we don't have anything he feels like he owns the park and he does everything he wants Mr. Alonso- in regards to this situation it has been going on a while we have talked about it in our meetings, it's a good idea to report this every week Mrs. Gonzalez- our Easter Egg Hunt will be next week in Arvin it will be on Friday March 29th, from 4pm-6pm and in Lamont it will be Saturday March 30th, 12pm-2pm if you guys want to join us and on April 1st we will start our Junior Giants registrations Mrs. Cervantes- I just want to make a comment regarding the Arvin Easter Egg Hunt it almost got cancelled because we are having problems with the City of Arvin with Cecilia she's been making it difficult for us to have our event she's asking for stuff that she hadn't asked before she's even making difficult for the city of Arvin they are working something out so we can have it this year but if she keeps doing what she's doing we might not partner with them anymore and do it on our own like we used to before Mrs. Gonzalez- that's also for Junior Giants she makes it very difficult for us to get the parks even if we request it ahead of time she always puts Arvin Little Legue first so we don't have any rights what we will be doing this year will be having practices in Arvin but all games will be here in Lamont some parents are not going to want to travel over here but that's the way we are going to have to do it, last year we had to call the cops because there

was another league coming in when we had it booked we can't be having coaches fighting so to prevent that we will be having are games in Lamont Mr. Rodiguezdoes this Cecilia have more authority than the City Manager if she's doing wrong you need to contact the city manager and let him know what's going on Mrs. Cervantes- I'm pretty sure his aware Mr. Rodriguez- maybe you should get in touch with the new mayor and with the boards permission I can go see the city manager Mrs. Cervantes- I will talk to the Mr. Hodges and I will let you know
