8.1 Maintenance -Mr. Villalpando- for the Bear Mountain Park we had our trees trimmed around the building and we also installed lights outside of the building and by the front doors the truck has been out of service since last week and maybe still next week so any work that needs to get done revolving the truck or trailer will be put off till next week, Weedpatch Park we are getting estimates for the restrooms the Arvin Pool the motor has burnt out again it's the third time within the year I don't know if you guys want to repair it I had the timer for the lights fixed the lights will be turning on and off now the trees have been trimmed as well at the Lamont Pool the valve has been repaired so we have the water back on, what I recommend regarding the pool there is a lot of iron metal on the bottom of the pool with that going on I suggest to drain the water out Mr. Rodriguez- the light by the door were you keep all the chemicals the light stay on during the day Mr. Villalpando- we just fixed that today we though it was the timer it was the wires they were rusted Mr. Perez-I noticed we took down the mural I notice there was s some graffiti underneath it or maybe it was graffiti that had been painted over Mr. Villalpando- we want to paint it all over to have everything one color Mr. Perez- we need to have a capital plan regarding the pools because that's a discussion we have to have, we should put that as an action item for the next board meeting, but definitely not replacing the pump at this time and we should drain the water following all the guidelines

a) Batting Cage PowerPoint- Mrs. Gonzalez- we did research and came up with prices of charging rates per hour for 40 dollars 1/4hour for 20dollars Mr. Rodriguez- I asked the District Manager to put this batting cage on the agenda because a citizen in Arvin that is involved in baseball he told me we have three baseball traveling teams in Arvin that's the reason I would like to push this because some of these people have to go all the way to Allen Rd to a batting range this will be really good for all these kids in Arvin Mrs. Gonzalez- the price for the Batting Cage not including the cement would be 20,000 dollars that would include four machines and it would include the self-pay Mr. Perez- I really don't like the coin feed aspect I would like it to be paid with credit card Mrs. Gonzalez- a lot of the coaches want to do a travel team and they would like for us to represent them I was thinking that if we charge each kid 180 dollars registration fee and a 50 dollar fee monthly and that would cover were they are going to go play at sports village every Sunday and it would also cover a fee to pay the coach and also for the referees, we would also provide uniforms and a soccer ball and the fee for the Sports village and the 250 tournament fee
