PUBLIC COMMENT- Gabriel Chavez- I just came because I got a paper from the District Manager that there was going to be fines that's my first point my next one is that we have more than five years playing soccer and we never had an issue the field has not been used for five years and now there are putting me a lot of obstacles for me to use it first one million dollar insurance now three million dollars insurance I don't know what the problem is there's never been any issues with the police since I started laying here there hasn't been any violence I would like sit with you guys to discuss this Sergio- I'm here to ask a few questions in regards to the state of the park Jose Sandoval- I'm from Bakersfield but are kids are playing in a tournament her in Lamont and the field should be able to be use be everyone and the restrooms are closed and not available either Mr. Rodriguez- can you answer any of these concerns Mrs. Cervantes- the restrooms were voted to be closed due to liability issues Mr. Hodges- the district has had a rental policy related to all the district facilities weather is this the park, Weedpatch Park, Picnic tables there's and entire policy that outlines what the breakdown is to rent that your talking about sharing the park like the baseball league and the soccer league that are out there those are district activities so they are going to take priority to anybody else using the park because those are 100 percent funded by the district and it's a district activity if you want to play there much opportunity to play as anyone out there except when the district activities are taking place they are going to take priority and all other times you are more than welcome to come and talk to the district manager and schedule times and actually have the entire filed for yourself there's a policy and application and you can book it out weeks in advance you can have a whole scheduled set up were your group has rented this and if you have a nonprofit is renting it is even cheaper to do the issue is coming up with the insurance and weather that an umbrella policy a general liability policy however you are going to do it you're going to submit that to the general manager she then runs it by the insurance company that insures the district and they can say yes this is going to work or no this is not going to work there's lots of ways the district can work with you to resolve this and I'm sure if you do rent it and you provide the security guard for access to the bathroom the board would be more than willing to allow you to use that because you would be insuring it with your insurance at that point and time and there is a way to resolve this but is not to have the district pay every time that they are destroyed that's what has happened people have gone in basically ripped the toilets off of the ground and broken every single part of it at the moment it opens up its destroyed so there is a way to resolve it and I recommend that you come and talk to the district manager because she's got the policy and she's got an application and they will be more than willing to rent it out ad make something happen that works with you and your kids because that's what the district wants to do Public- renting it out it gives us access to the restrooms Mr. Hodges- yes if there are some terms outline and your insurance is covering then there wouldn't be a problem you'll get a key to the restroom and one you would be responsible for opening it up and you turn the key back when your done with the rental if you rent it you have the entire field to yourself nobody else can us it Gabriel Chaves- the insurance had been going up one million, two million, three million and I have been selling tacos and nobody has gotten sick and why are you doing this now. Mr. Perezthank you for your comment, we don't set the insurance rate unless his permitted is not legal selling food Mr. Alonso- I just want to make a comment on the comment that was made that there was no issues in the last five years I can't say specifically that there hasn't

been any issues in the last five years but in moving forward everything does have to be legal everything has t be under the law, correct me if I'm wrong we do have does applications for you there is a prosses that applies to everybody you mention that there are a lot of families that are affected but there is a lot of families effected in our side as well that are involved in our district program there are also kids and there families as well for my understanding when its during our soccer season and baseball that is gong to take priority ad aside form those times everybody is going to have the opportunity to apply for those time slots, like mention with the insurance we don't control those rates, the district has more recreation activities than in the past **Mr. Perez-** in the past we have talked about a key system in renting the field is that still in place **Mrs. Cervantes-** when Mr. Chaves has rented the field before he would get the restroom keys and he got fingered printed to be able to get the key so who ever rents it and wants to get a key needs to get fingerprinted

Mrs. Cervantes- we went to a conference the week of May 21<sup>st</sup> and at the conference they let us know that there's a workplace violence prevention plan that needed to be in place for July 1st so I was at the conference I was sending all the information to Nathan because they said it had to go through our attorney when we put this in place is something CAL OSHA is requiring and I in contact with our insurance to see if its something that is being required so that is something our attorney has been working on and his going to be giving us a training next week, I also had a budget committee meeting I did not have the five year plan committee meeting I will try to scheduled that in August, July is going to be a busy month because I'm going to be working on the audit the week of the July 8th I will be having the financial audit and the week of July 21<sup>st</sup> I will be having the insurance audit that is something that Mr. Villalpando will be working on checking all the facilities making sure everything is in order and like Mr. Villalpando mention summer started the pool will be open June 18<sup>th</sup> – July 28th for six weeks we have had 30 kids come so far, it's a good starting we will never have the money we put out but at least we had the 30 kids the first two days, we have also had some ,meetings with the solar company and there is a resolution on here that you guys will talk about, Mr. Perez and Mr. Hodges met with the solar company and the bank and then Mr. Hodges and myself met with them at another meeting, we have been working on the purchasing policy as well we had an outdated credit card policy so that is something that he added to the purchasing policy that he provided last month we added a new credit card policy, we have been working in a lot of different things
